**INVITATION TO BID
FOR PURCHASE OF MOTOR VEHICLE**

1. The Philippine Consulate General (PCG) in Toronto (Consulate), through the allotment authorized by the Department of Foreign Affairs intends to apply the amount of Two Million Pesos only (Php2,000,000.00) or its equivalent in US Dollars being the Approved Budget for the Contract (ABC) for Capital Outlay of this Post to purchase one (1) Motor Vehicle (Passenger Van). Bids in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Consulate General in Toronto, through its Bids and Awards Committee, now invites bids for one (1) motor vehicle (passenger van). Delivery of the Goods is required after seven (7) days. Bidders should have completed, within seven (7) days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from the PCG in Toronto and inspect the Bidding Documents at the address given below during 9:00 am to 4:00 pm.

A complete set of Bidding Documents will be available to interested bidders on 31 July 2017 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Two Thousand Pesos (Php2,000.00) or its equivalent CAD\$ at the Philippine Consulate General Cashier.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) www.philgeps.gov.ph and the website of the Philippine Consulate General in Toronto, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The Philippine Consulate General-Bids and Awards Committee has scheduled the following activities for the said Project which shall be open only to all interested parties who have purchased the Bidding Documents:

Bid opening shall be on 15 August 2017 at 2:00 pm at the PCG Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The PCG-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to awarding of contract, without thereby incurring any liability to the affected bidder or bidders.
