The Philippine Consulate General in Toronto, through its Bids and Awards Committee (BAC), hereby invites all eligible distributors/service providers to bid for the following:

BRIEF DESCRIPTION

The distributor/service provider shall lease to the Consulate the digital photocopying machine with sorter, automatic back-to-back copying, network printer, fax and scanner, stapling capabilities, color &

b/w, automatic feeder, 55-60 pages per minute.

Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents particularly in the Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the Revised IRR of RA 9184.

Interested bidders may obtain further information from the PCG in Toronto and inspect the Bidding Documents at the address given below during 9:00 am to 4:00 pm.

A complete set of Bidding Documents will be available to interested bidders on 9 February 2018 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Two Thousand Pesos (Php5,000.00) or its equivalent CAD\$ at the Philippine Consulate General Cashier.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) <a href="https://www.philgeps.gov.ph">www.philgeps.gov.ph</a> and the website of the Philippine Consulate General in Toronto, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
