REQUIREMENTS

1. Duly accomplished Application Form
2. Four (4) passport-size colored photo, white background, taken within the last 6 months clearly showing the full front view of the face
3. Old Philippine passport or documents evidencing Philippine citizenship (original & 2 photocopies)
4. Travel itinerary or airline tickets (2 photocopies)
5. Fee of C\$40.50 payable in cash, certified check or postal money order to the Philippine Consulate
6. Two (2) copies of Deportation or Removal Order or Proof of immigration status (e.g. work permit/ permanent resident card)
7. Two (2) copies of proof of urgency/emergency or supporting documents (e.g. Death Certificate, Medical Certificate, etc.)
8. Pre-paid return courier envelope for applications through mail

NOTE: (1) A travel document may be applied only for emergency reasons or urgent cases and should not be used for convenience in order to avoid going through the passport renewal process; (2) A Travel Document is valid for a maximum of 30 days from date of issue and must be used for direct travel to the Philippines.
